



- in rainy weather. • Do not subject the light to strong vibrations, impacts, or excessive force. Discontinue use if any abnormality occurs.
- · Do not charge or use the battery at any voltage or polarity other than that specified. Do not short-circuit the battery.
- · Do not drop the light into a fire or heat the light.
- · If the light unit or parts become dirty with mud, etc., clean with a soft cloth which is moistened with mild soap. Never apply paint thinner, benzine or alcohol; damage will result.

# A LITHIUM-ION BATTERIES

#### Recharge the battery for first time use or after long period of storage:


The voltage of the battery may drop due to self-discharge during long period of storage. Always fully charge the battery before use.

#### Cautions for charging and usage:

- We recommend using 0.5 A USB battery charger.
- · Please be sure that no dust or other foreign objects are attached to the plug of the USB cable before charging.
- Do not subject the light to vibrations while charging. . When your PC is in sleep state, the unit cannot be
- charged
- Once charging is completed, be sure to disconnect the USB cable from the charging port.
- Charging time is approximate values, and will vary depending on the environmental and usage conditions.
- Charging, discharging, and storing in high temperatures will cause the rechargeable battery to deteriorate faster. Do not place the light inside a vehicle or near a heater. Make sure to charge only when the ambient temperature is between 5 and 40°C.
- If the illumination time is significantly reduced even after proper charging, the rechargeable battery may be nearing the end of its service life.

#### Cautions on storage:

- If the device will not be used for a long period of time, store it in a location that is not too hot or too humid.
- Charge the battery for about 30 minutes every 6 months. **Cautions for dispose:**
- When disposing the light unit, please do so in accordance with your local regulations.



SWITCH OPERATION

#### Automatic battery-saving function:

When the remaining battery power gets low, the indicator starts flashing and the lighting mode changes to power-save flashing mode (where the LEDs on both ends of the unit flash alternately). Charge the product as soon as possible.



# HOW TO MOUNT TO A BICYCLE

Attach the light securely in the mounting position. Horizontal unit Ladder rubber band 2 Bracket Attach the ladder Mount the light unit vertically or rubber band (B) to the horizontally. bracket (A). Seat post/stay Ø21.5 – 32 mm 5 Fold back Fold back any excess band
